SOVIET CAN GIVE 'PEOPLE MOST--K

Some U. S. Leaders Fear Thaw, He Says

MOSCOW (AP)—Premier Nikita Khrushchev has said the Soviet Union can give its citizens five times as much as their American counterparts.

"I think that if necessary--unless the stomach disagrees--we can provide five American rations for every Soviet citizen."

"FOOL WORKING PEOPLE" "It is no accident that they invent various new terms, new names like 'peoples capitalism' and 'humane capitalism' in order to fool the working people, to mislead them."

"POSITION NOT CHANGED" Khrushchev noted that the holy alliances all disappeared "and so it will be with the present NATO, SEATO and CENTO--they will all disappear leaving nothing but unpleasant memories, because the peoples will not tolerate iron on their hands."

"We are for talks," he said, "and we want to prove that if the Western powers really want to clear the way for friendly relations between our states we should together remove the stones from the road along which we should advance, each from his side, to ensure peace and the security of the peoples."

BROWNSVILLE, Tenn. (AP)—A Negro farmer testified Tuesday he shot the sheriff of this racially tense county when the white officer threatened to kill him.

ON FRONT PORCH

Jones testified he and his family were on the front porch when two strange white men drove up and one of them was looking for "Willie T. Jones."

"I told him I don't know a Willie T. Jones," he said. "Yes, there's a Jones in here somewhere close. I told him I was Willie Jones but not Willie T."

"He got out of the car with a gun in his hand. He said, 'You ... you're the nigger I'm looking for and I'm going to kill you.' I ran in the house and got my gun. Next time I saw him he was at the back door. He had the screen pulled open and was sticking a gun in the door. I shot."
