

# PLAY BOARD TO DECIDE SOON ON TOURIST PLANS

## No Money Provided Now In New City Budget

The fate of winter orchestra concerts and maintenance of the tourist recreation center in Plant park next season will be decided by the city recreation board next week at a special meeting called to consider reappropriation of the half million appropriation included in the new municipal budget.

The recreation department budget, as now drafted, does not include any money for tourist entertainment, either in the operation of the city park pavilion or the orchestra concerts. Refusal of the board to change the budget will mean the city's participation in the general tourist program will be abandoned in favor of spending the entire \$50,000 appropriation on expansions of playgrounds.

### Would Divide Fund

Walter F. Pierce, board member, came out yesterday in favor of splitting the appropriation between playgrounds and tourists.

"I will insist upon setting aside not less than \$25,000 for tourist activities, including the orchestra fund," Mr. Pierce said. "This would leave \$34,000 for playgrounds, which would be sufficient if certain economies are effected in reducing the present force of supervisors and assistants."

The present method of playground operation, according to Mr. Pierce, affords the recreation board ample opportunities for retrenchment. He believes one supervisor per playground would be sufficient to carry on the department's activities, explaining that certain recreation areas are in charge of two staff employees.

### Could Cut Expenses

"There are certain playgrounds," Mr. Pierce said, "requiring the services of a woman as well as a man. But these are in the minority. Other savings could be made in the general program, sufficient to operate efficiently within the proposed \$34,000 appropriation."

Several civic organizations interested in tourist entertainment are expected to attend the recreation board meeting. With the board of aldermen refusing any appropriation for the chamber of commerce, this group, through its tourist and convention committee, probably will be represented by a big delegation. The merchants' association is also interested in the outcome of the board's budget meeting.

Failure of the board to set aside funds for the tourist recreation center, chamber of commerce officials said yesterday, might be followed by the elimination of the tourist and convention committee.

### Sarasota City Council Waives Back Tax Costs

SARASOTA, July 18.—(Special.)—Delinquent taxpayers in this city have until Sept. 1 to clear city taxes payable as far back as 1926 at their face value with penalties waived as a result of a 3 to 2 vote of the city council despite warnings of City Attorney Harrison E. Barringer and Mayor Everett J. Bacon that the action was illegal. They are supposed to be the last in the city's fight against delinquents before it starts foreclosure proceedings for back taxes on Sept. 1.

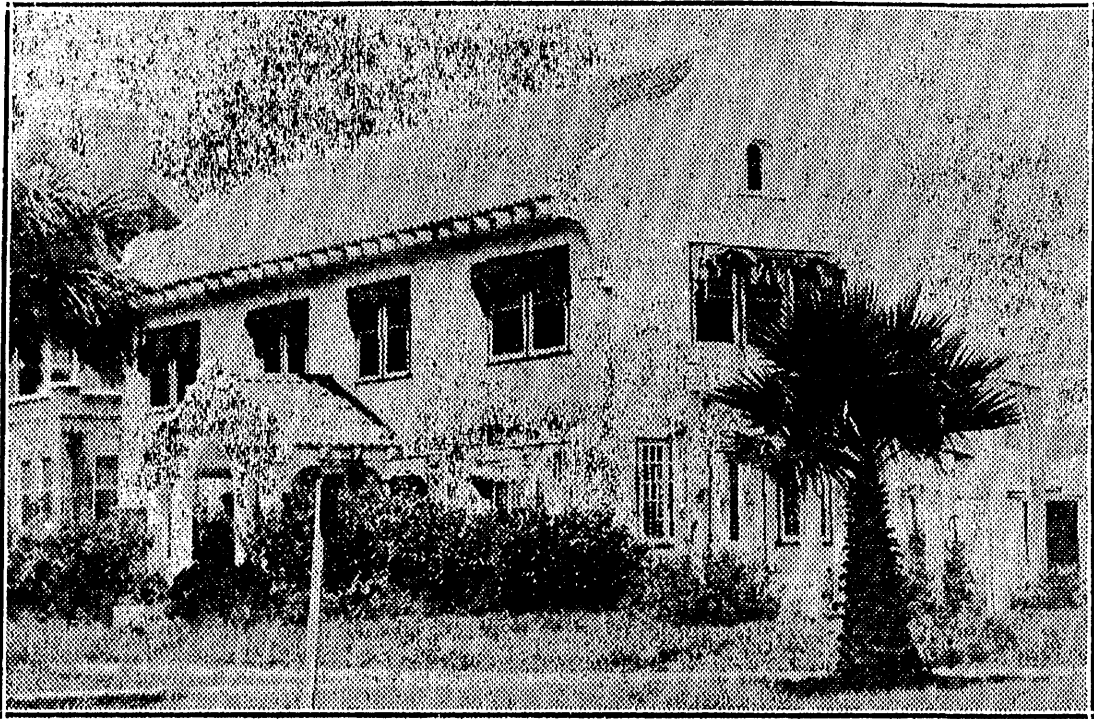

## CENTRO TO OPEN 24-HOUR LATIN FIESTA TONIGHT

### Continuous Program Arranged at Rocky Point

Wholesale whoopee, with ample entertainment for those folk who never want to go home, will be provided at the Spanish fiesta at Rocky Point, which will begin tonight at 8 o'clock and continue until tomorrow night at the same hour with a perpetual program of entertainment.

It will be a big party done in a big way under auspices of the Centro Asturiano. Three thousand persons are expected to attend some time during the program which has been patterned after those fiestas held in Spain for centuries.

There will be bathing beauty contests, of course; "blues" singers will mean in competition; fireworks will flare from the ground and sea; and incidental prizes include a baby show, dancing, music and feasting. Maximo Gonzalez heads the committee in charge of arrangements.

### Girls to Give Dance

Gates will be opened tonight at 8 o'clock and the first 50 persons will not be charged an admittance fee. At 8:30 o'clock dancing will begin in the honky tonk with music by the Varsity Boys. A prize fight will be held at 9 o'clock and at 9:30 o'clock 200 girls from the Juventud Estuasiasta will present a costume dance.

A Cuban orchestra will begin playing at 10 o'clock and there will be prizes for dancers. There will be fireworks from the ground and from the air by a seaplane at midnight and a Spanish dance contest will be held. This will be followed by competition in singing.

### "Blues" Singers to Compete

A prize will be awarded at 1 o'clock for the best "blues" singer and a surprise is promised at 1:30 o'clock. Prizes for the prettiest girls will be presented tomorrow morning at 9:30 o'clock and the regular program will begin again at 11 o'clock with morning mass by the Rev. Conde. This will be followed by a bathing beauty contest and a country dinner will be served by the Juventud Estuasiasta at noon.

There will be prize fights tomorrow afternoon at 1 o'clock and Spanish dancing at 1:30 o'clock. The Varsity Boys will begin playing at 2 o'clock and at 3 o'clock a prize will be awarded to the best waltzer. At 4 o'clock there will be a greased pole contest for boys and at 5 o'clock girls will give a boxing exhibition. A baby show also will be held.

### Manatee Tri-Cities To Consider Consolidation

BRADENTON, July 18.—(Special.)—First official action toward the consolidation of Palmetto, Manatee and Bradenton has been taken by the Palmetto city council, which, by unanimous action at their recent meeting, named a committee consisting of Mayor B. F. Mount, Councilman E. F. Hayes, and City Attorney J. B. Piqua, to work with similar committees to be appointed by Manatee and Bradenton councils, and a representative of the bonding companies.

At the meeting of the Manatee council Monday morning at 9:30 o'clock at the city hall, Mayor W. R. Allison, a member of the committee recently named by the board of directors of the chamber of commerce of Bradenton to draw up resolutions calling for the appointment of committees by the three city councils, will bring the consolidation matter up before that body, urging that a committee be named.

## Road Board Awards Contracts for New Construction Work

TALLAHASSEE, July 18.—(A.P.)—The state road department closed its quarterly meeting today by awarding contracts for public improvements in scattered sections of Florida.

In many instances the board agreed with the requests of the delegations appearing during the session and promised to include the proposed projects in next year's road department budget.

The matter of assuming the cost of rejected material in the Peace river bridge project where federal engineers representing the government's part in financing the structure have rejected much material, occupied much of both days' sessions. It was finally agreed that the contractor will assume the cost of rejections up to 7 percent and the state road department all over 7 percent.

The department agreed to take over the maintenance of a section of road 30 at Vero Beach.

### Feist Wills Trust Fund Of \$100,000 to Charity

WHITE PLAINS, N. Y., July 18.—(A.P.)—A trust fund of \$100,000 to be known as the "Leo Feist charities trust" and to be used for "the temporary relief of needy persons," was provided for in the will of Leo Feist, New York music publisher, filed today.

The estate of Feist, who died at his Mount Vernon home on June 23, was estimated today at about a million dollars.

The widow, Mrs. Bessie Feist, and the sons, Nathan, Milton and Leonard, are given personal effects and an interest in a trust fund to which the residuary estate is to be applied.

### Dade County Votes Fund For Bank Investigation

MIAMI, July 18.—(A.P.)—Dade county commissioners today voted an appropriation not to exceed \$6000 for investigation of affairs of the Bank of Bay Biscayne, which closed its doors June 11. The investigation would be made through cooperation of State Attorney N. Vernon Hawthorne and County Solicitor George McCaskill.

McCaskill asked the county commissioners for the funds on the grounds that employment of an outside auditor to make an independent examination of the suspended bank's books was necessary.

## HILLSBOROUGH AVENUE BRIDGE REPAIR SOUGHT

### Petitioners Ask Commission for Action

A large delegation went before the county commission yesterday and filed petitions signed by 142 citizens living immediately north of the city, protesting against closing of the Hillsborough avenue bridge and failure of the officials to repair the structure. The bridge was ordered closed to traffic by the commission about three months ago, upon a report of A. B. Pimm, county engineer, that it was in a decayed and dangerous condition.

Members of the delegation, saying that traffic on West Hillsborough avenue averaged more than 500 automobiles daily, protested that their business interests were being damaged by reason of diverting the traffic over the Sligh avenue bridge and other routes. Others complained that operation of their cars over the diverted routes cost them an average of \$7 a month each extra expense.

### Say No Funds Available

Chairman Williams told the delegation the commission had no funds to repair the bridge, and that the board had failed in efforts to get the state road department or the city to share the expense in making the improvements. Engineer Pimm said it would cost about \$6000 to make temporary repairs and make the bridge safe for travel.

"The commission is fully aware," Chairman Williams said, "of the hardships caused residents of the North Tampa section by reason of closing the bridge. We also know that the bridge must be repaired, and we want to assure those affected that the improvements will be made just as soon as funds are available."

Charity Appropriation Sought. Officials of the Family Service association asked the commission to make an appropriation of \$5000 to cover an actual shortage in the association's budget in providing for needy and unemployed families of Tampa and the county. The delegation was composed of C. W. Lyons, vice president of the association; Mrs. Elizabeth Rowe Caro, secretary, and M. J. Mackler.

The commission took the petition under consideration, and agreed to confer with members of the delegation next week to determine if an appropriation can be included in the commission's budget for the ensuing fiscal year, to be adopted in September.

### Two Children Die in Flames as Home Burns

WHITE CLOUD, Mich., July 18.—(A.P.)—Two children were burned to death today in the farm home of an uncle, which was destroyed.

The victims, Richard Trigger, 13, and his sister Marion, 9, were trapped in bedrooms on the second floor by flames. Their uncle, William Paulsen, with whom they were staying while their parents were in Chicago, and his wife, who slept on the ground floor, escaped.

TAMPAN'S CATCH BIG TARPON SARASOTA, July 18.—(Special.)—Two Tampa men entered catches in the international tarpon tournament here. They were Bundy Allen and W. P. Hughes. Allen recorded a 45-pound tarpon caught with light tackle and Hughes brought in a 68-pounder with heavy tackle.
