CONVICT PARDONED THAT HE MAY TAKE OFFICE OF SHERIFF

Robert T. Mansker Now Honored and Respected Citizen of New Mexico.

In order to allow a man to accept the office of sheriff of his county, to which he has been overwhelmingly elected, Governor Shafroth granted an unconditional pardon Wednesday to Robert T. Mansker, pardoned twenty years ago and not fired a shot at his antagonist until the latter had fired three bullets at him, was found guilty of manslaughter and sentenced to four years in the Canon City prison. He entered the gates of that institution believing himself to have been fully justified in the killing which he must expiate, but resolved to keep himself as free from bitterness as circumstances would permit.

Mansker proved a model prisoner. On the last day of the year 1892 he was pardoned. Nominally he was a free man, at that time he went to the city and as he liked within the bounds of the law, but he knew that, in reality, he was still a prisoner, and that at the word of the penitentiary warden he could again be placed behind the bars.

He decided to go to New Mexico and there took up a small farm. Success attended his efforts and he was soon regarded as one of the dependable citizens of the community. Everyone with whom he had occasion to deal liked the man, finding in him none of the bitterness and acrimoniousness usually resulting from prison experiences such as he had undergone.

Urged repeatedly to run for some county office, Mansker always refused, until preparations for the recent campaign were begun. Then, yielding to the persuasion of friends, he accepted the nomination for sheriff and "went in to win."

He had never attempted to conceal the fact of his years in prison, but his political opponents decided to embellish the story a bit and make it the basis for their fight against him. In the telling, from street corners and wagons and campaign stands throughout the county, the tale of twenty years ago held none of the element of self-defense which was so great a part of it. The people were told that Robert Mansker killed a man, was found guilty and served a term in prison. No exception should be made either of the law for them and their families.

And the people listened. And on election day they went to the polls and voted for Robert Mansker for sheriff. They are political allies, endeavoring to poison his triumph by a final sting, derived from the constitution and cried aloud that he had found a provision barring any executive from holding office unless he received the unconditional pardon of the governor in the state where he had been sentenced.

Petitions on Mansker's behalf were sent by his determined friends to the governor of New Mexico. He placed the matter before Governor Shafroth, and yesterday the latter signed an unconditional pardon, permitting Mansker to accept the office from the hands of those who know and believe in his worth.

CARRIER PIGEON KILLED IN FLIGHT

Was Carrying Message From Salt Lake to Kansas City—Wire Caused Death.

As W. L. Jewett was passing the Sixteenth street side of the Denver Dry Goods company at 5 o'clock Tuesday evening he was almost knocked down by something hitting him on the head. Investigation proved that it was no hostile weapon that some enemy had hurled at him, but a homing pigeon, which was on its way from Salt Lake City to Kansas City, Mo. There was a small wound in the body of the pigeon on the right side under the fore part of the wing. From the shape of the wound it appears that the pigeon hit a sharp wire in its flight. Around the neck of the pigeon was a message written on a piece of paper, about an inch wide and two inches long.

The paper was folded into a tiny packet a half inch long and an eighth of an inch wide, then sewed with a silk thread and tied around the pigeon's neck. On it was written the following message:
Salt Lake, 11-18-11.
Dear Ruth—The carrier has been apparently sick, but seems all right this morning, so will turn it loose. Hoping it reaches you O. K. With love from Jack and I. We expect to eat Xmas dinner with you. Tell mother and Roy hello.
HARRY.
On the reverse side of the paper was a request that the message be forwarded to Miss Ruth Mason, 927 Clinton, Kansas City, Mo., in case the pigeon should meet with any accident.
The pigeon is one of the smaller variety, gray, with neck and wing feathers tipped with tan. Mr. Jewett turned the pigeon over to A. T. Allan, 1750 California street, who will attempt it for Mr. Jewett or the former owners should they claim it.
From the date of the message the pigeon had spent three days reaching Denver.

PETITION ATTACKS THE FOOD TRUST

Hotel and Restaurant Men Say Prices Are Highway Robbery.

A petition now in circulation among hotel and restaurant men who say they are forced to pay two profits on the goods they purchase, is being liberally signed, the object being to show, by a multiplicity of signatures, the sentiment of the general public regarding the discrimination made in the matter of selling groceries and similar goods to those residing or doing business outside the so-called zone established by the Denver Retail Grocers' association.

The petition sets forth that the Retail Grocers' association and the wholesalers have formed an agreement whereby hotel and restaurant keepers in a certain described district in the heart of the city are allowed the privilege of buying direct from the wholesaler, whereas those outside this district must buy from the retailer and pay his profit as well as the profit the retailer pays the wholesaler.

The petition compares this discrimination with highway robbery. The "lines of favoritism," as the petition describes the boundaries of the "zone," are given. The "district" is bounded by these streets: Thirteenth, Nineteenth street, Platte River to Colfax, Colfax to Lincoln.
